at least five new members from your club membership base (which is listed on the report referenced above). As mentioned in the last few months there is a fun contest for a club to achieve President's Distinguished status **EARLY** by April 15! The prize is that one club member of the President's Distinguished club will have the opportunity to throw a pie at one of the Trio members during the 2013 Spring Conference in Kearney, NE. Each club can select which Trio member is on the receiving end – Sheri, Kathy or Shellie!

There are noteworthy changes, highlighted by a diamond mark in the left margin in the 2013 Speech Contest Rules, such as:

**Page 8, Section 4 Speech Subject and Preparation, D, # 2 –** “Twenty-five percent or less of the speech may be devoted to quoting, paraphrasing, or referencing another person’s content. Any quoted, paraphrased or referenced content must be so identified during the speech presentation.”

**Page 10, Section 5 General Procedure, E, # 1, f) –** “All judges receive the Judge’s Certification of Eligibility and Code of Ethics (Item 1170). The form must be signed and returned to the chief judge.”

**Page 19, Contest Chair’s Checklist,** After the Contest, # 1, “Provide the contact details for all contestants to the chief judge so he or she can complete the Notification of Contest Winner form (Item 1182). Confirm that the chief judge gives this form to the contest chair of the next level or to World Headquarters in the case of the International Speech Contest at the district level.”

The 2013 District 24 Spring Speech Contests will be the International Speech and Evaluation Contests. To qualify as a contestant, you must be a member in good standing, in an active club with Toastmasters International. For the International Speech Contest, you also must have presented at least six speeches from your Competent Communication manual. District 24 Club Speech Contests are to be held between Feb. 4 and March 1; Area Speech Contests are being held between March 2 and March 30; and Division Speech Contests are being held between March 31 and April 13. The Area and Division Speech Contests schedule is attached.

The District 24 Spring Conference will be held on April 26 -27, in Kearney, at the Holiday Inn Hotel & Convention Center. Division Evaluation Speech Contest winners will compete on April 26; Division International Speech Contest winners will compete on April 27. John Paul Arias is our 2013 Spring Conference Chair. During the "Talk Up Toastmasters!" membership contest, you can encourage your members to invite guests to a special meeting where regular procedures are augmented by a discussion of Toastmasters' many

benefits. Add five new, dual or reinstated members to your roster between Feb. 1 and March 31 to receive a special "Talk up Toastmasters!" ribbon to display on your club's banner. Membership applications and payment for members who join between Feb. 1 and March 31 must be received at World Headquarters or online no later than March 31. Each member's join date as listed on the application must be in Feb. or March. Transfer and charter members do not count for credit. In addition to the ribbon, qualifying clubs will also earn a special discount code for 10% off their next club order.

Also, Don't forget the 1+1 incentive from Toastmasters International President, John Lau. The 1+1 campaign is a membership-building program designed to help grow and strengthen our great organization. Beginning Dec. 1, 2012, when you refer a friend who becomes a Toastmasters member, you can fill out the 1+1 form so that your efforts can be recognized. The 1+1 membership-building campaign is valid through June 30, 2013.

Members who have referred a friend that joins a Toastmasters club will receive a 1+1 decal and a personalized letter from Executive Director, Daniel Rex and John Lau, International President. This letter will be presented to members by club presidents. Also, each month, the referring member's name will be listed on the 1+1 web page wall. To

## District Officer Training

Although your District Officers (the Trio, Secretary, Treasurer, Public Relations Officer, Division Governors, and Area Governors) have been meeting each month for training and District Executive Committee meetings, they are required to attend bi-annual training just as club officers attend TLI's. The second round of training was held on Dec. 1. The 8:00 a.m. to 3:00 p.m. session included a



breakout lunch, with each Division Governor meeting with his or her Area Governors. Marian Gramlich, Area B11 Governor, presented on her High Performance Leadership project, which is focused on updating the District 24 member email list. Past International Director Floy Westermeier instructed the group on handling credentials for a district conference, which enables the district to reach a quorum and conduct official business at the fall and spring conferences. District Governor Sheri Wells-Chesley led a communication exercise, having listeners follow directions in tearing a piece of paper to create a snowflake. (Note that everyone followed the same directions!) Much of the meeting was spent in strategic planning for the district over the next 5 years, with attendees voting on the most important objectives to achieve and developing specific goals to match those objectives.

## Parliamentary Procedure: The Agenda

### ***Why have an agenda or program?***

To point out the obvious, it lets all of the participants understand how to prepare and what to expect. Like following a standard Order of Business as we discussed last month, an agenda can improve the effectiveness of the body. As stated in RONR (11<sup>TH</sup> ED.), p. 372, II. 2-9 “It is customary to adopt an agenda ... when, for any reason, neither the standard order of business nor a special order of business established by rule of the organization is practical or applicable”.

An agenda is a tool that lets the members agree on the order and even the time to address the business of the group. As we know, when a group meets there is always an agenda—whether it is shared for the benefit of the members of the assembly is the question.

### ***How do I use the agenda?***

If you are the chair, use it as your tool to plan the meeting. Determine what needs to be addressed, in what sequence, for how long, and even if necessary the exact time a subject will be discussed. Compare this with the time and resources available. Each particular subject, question or item of business (sometimes called an *order of the day*), can either be considered a general or special order.

Special orders are items that need to be addressed at a certain time and have priority over other orders. Use special orders to make sure that a certain order is

addressed at a certain time. Only questions of adjournment, recess or privilege (or a previous special order) can interfere.

Armed with this knowledge, develop a draft agenda. Present the agenda to the members. If approved by a majority, proceed to conduct the meeting per the agenda. Moving from one item to the next is a matter of sequentially following the plan and making sure that special orders are addressed at the noted times. Your meeting is on its way to being productive and on time!

If you are member of the assembly, the agenda helps you make the meeting more productive by knowing what will be discussed and in the case of special orders, when that item will be discussed. Read it carefully to help you prepare and before approving. It is approved by a majority of the members and can only be changed by a two-thirds majority. The agenda can greatly improve the ability of the group to facilitate action, to express its will and produce results.

As your district parliamentarian (meaning a member of the district who is learning how to use parliamentary procedure in district meetings) I will share as time allows more about this mysterious process called parliamentary procedure. Next month we will start down the path of motions!!

Toastmasters International is comprised of 14 regions which are further divided into nearly 90 Districts. District 24 is part of Region IV, which includes the U.S. states of Iowa, Minnesota, Montana, Nebraska, North Dakota and South Dakota as well as the Canadian provinces of Alberta, Ontario, Manitoba, and Saskatchewan. The boundary of District 24 is as follows: The State of Nebraska, less the western panhandle area, which starts at the western boundary of Keith County and follows north along the western boundaries of Arthur, Grant, and Cherry Counties ending at the South Dakota border, plus the western portion of Pottawattamie County, west of Highway 59, less Dakota County in Nebraska.

Membership in Toastmasters is one of the greatest investments you can make in yourself. At \$36 every six months, it is also one of the most cost-effective skill-building tools available anywhere.

### How Does It Work?

A Toastmasters meeting is a learn-by-doing workshop in which participants hone their speaking and leadership skills in a no-pressure atmosphere.

There is no instructor in a Toastmasters meeting. Instead, members evaluate one another's presentations. This feedback process is a key part of the program's success.

Meeting participants also give impromptu talks on assigned topics, conduct meetings and develop skills related to timekeeping, grammar and parliamentary procedure.
